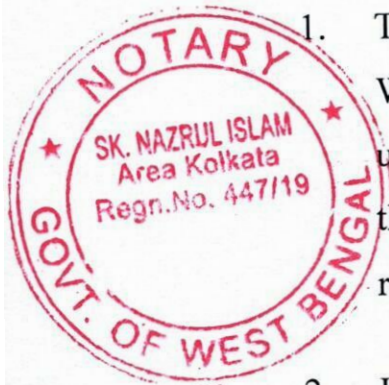

5. That this Hon'ble Court vide order dated 20.03.2023 directed as follows:



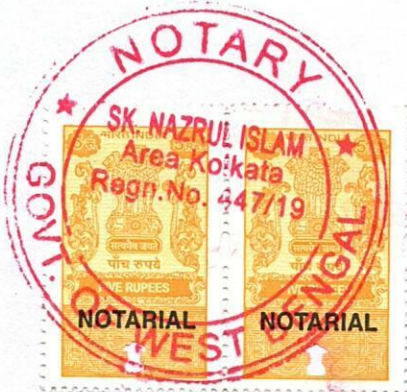
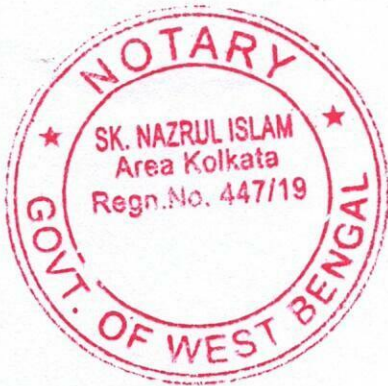

This exercise shall be completed within a period of three months from the date of the order.”
