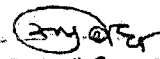

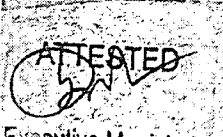
2. I state that the above Contempt Petition has been filed by the Petitioners for initiation of contempt proceedings against the Alleged Contemnors/ Respondents, alleging that the Judgment dated 20.03.2023 passed by this Hon'ble Court in Writ Petition (C) No. 1040 of 2019, titled *Pravasi Legal Cell v. Union of India & Ors.* has not been complied with.

3. In *Pravasi Legal Cell* this Hon'ble Court directed as under-

"Writ Petition (Civil) No. 1040 of 2019

1. In view of the orders which have been passed in Writ Petition (Civil) No. 1325 of 2020, there shall be a direction to all the State governments/ Union Territories to set up and operationalize online web portals so that information sought under the Right to Information Act 2005 is made available in respect of all public authorities falling within their jurisdiction. This exercise shall be completed within a period of three months the date of this order."

4. In the present Contempt Petition, the Contempt Petitioner has alleged the following deficiencies in respect of the online RTI portal administered by the Government of Himachal Pradesh:

a. **That** only a limited number of District Magistrates within their jurisdiction are available in the RTI portal. (Page No. 17, Para 16(A)(a))

b. **That** State Secondary Education Boards have not been enlisted in the RTI portal. (Page No. 18, Para 16(B)(c))

c. **That** State Medical Councils have not been enlisted in the RTI Portal. (Page No. 18, Para 16(B)(d))

d. **That** the CAPTCHA feature required to submit the RTI application on the portal violate GIGW 3.0 Guideline 5.2.1(e), as it is not disabled-friendly. (Page No. 21, Para 19)

5. It is submitted that, recognizing the importance of providing a single point access to all information and services mandated by the RTI Act,

the State of Himachal Pradesh⁴ launched an online RTI portal (<https://onlinerti.hp.gov.in/site/about>) back in 29.12.2021, i.e., before the judgement passed by this Hon'ble Court in *Pravasi Legal Cell*.

6. By means of the online portal, the aim of the State is two-fold, i.e., (a) to ease access to information to citizens and, (b) to ensure that the said information is provided in a time bound manner. The introduction to the Portal ('About Us') itself states that Public Authorities would be liable to be penalized for not adhering to the time-limit for disposal of a request for information.

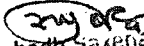

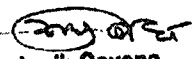

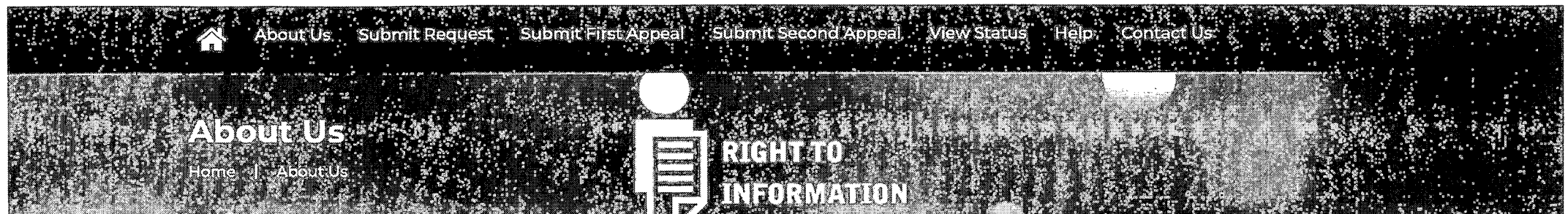

RTI stands for Right To Information and has been given the status of a fundamental right under Article 19(1) of the Constitution. Article 19 (1) under which every citizen has freedom of speech and expression and have the right to know how the government works, what role does it play, what are its functions and so on.

Right to Information Act empowers every citizen to seek any information, take notes, extracts or certified copies of documents or records, take certified samples of material.

The RTI Act extends to the whole of India (except the State of Jammu and Kashmir), all bodies, which come under Government notification including NGOs, which are owned, controlled or are substantially financed by the Government.

This Portal has been developed with an objective to provide single point access to all information and services mandatory under the RTI Act, 2005 in respect of all public authorities / Government Offices / Organisations of Government of Himachal Pradesh. Therefore, an attempt has been made through this Portal to provide comprehensive, accurate, and authentic information on implementation of Right to Information Act, 2005 in the system of governance in Himachal Pradesh.

By using this account, every Public Authority has the advantage of adhering to prescribed time-limit for disposal failing which he/she is liable to be penalised. At the same time the citizen has the satisfaction in obtaining information from the PIOs in due time, thus, posing trust on the Govt. system. This software also generates all the registers as prescribed under the Himachal Pradesh Right to Information Rules, 2005.

We continue our effort to enrich this portal on the basis of your valued opinion and suggestions. We look forward in this direction.

RTI

GUIDELINES FOR USE OF RTI ONLINE PORTAL

- » This Web Portal can be used by Indian citizens to file RTI application online and also to make payment for RTI application online. First appeal can also be filed online.
- » An applicant who desires to obtain any information under the RTI Act can make a request through this Web Portal to the Government of Himachal Pradesh.
- » On clicking at "Submit Request", the applicant has to fill the required details on the page that will appear.
- » The fields marked*are mandatory while the others are optional.
- » The text of the application may be written at the prescribed column.
- » At present, the text of an application that can be uploaded at the prescribed column is confined to 10000 characters only.
- » In case an application contains more than 10000 characters, it can be uploaded as an attachment, by using column "Supporting document".
- » After filling the first page, the applicant has to click on "Make Payment" to make payment of the prescribed fee.
- » The applicant can pay the prescribed fee through the following modes:
 - (a) Internet banking through SBI;
 - (b) Using credit/debit card of Master/Visa;
 - (c) Using RuPay Card.
- » Fee for making an application is as prescribed in the RTI Rules, 2006 amended time to time.
- » After making payment, an application can be submitted.
- » No RTI fee is required to be paid by any citizen who is below poverty line as per RTI Rules, 2006 amended time to time. However, the applicant must attach a copy of the certificate issued by the appropriate government in this regard, alongwith the application.
- » On submission of an application, a unique registration number would be issued, which may be referred by the applicant for any references in future.
- » In case additional fee is required representing the cost for providing information, the SPIO would intimate the applicant through this portal. This intimation can be seen by the applicant through Status Report or through his/her e-mail alert.
- » For making an appeal to the first Appellate Authority, the applicant has to click at "Submit First Appeal" and fill up the page that will appear.
- » The registration number of original application has to be used for reference.
- » As per RTI Act, no fee has to be paid for the appeal.
- » The applicant/the appellant should submit his/her mobile number to receive SMS alert.
- » Status of the RTI application/first appeal filed online can be seen by the applicant/appellant by clicking at "View Status".
- » All the requirements for filing an RTI application and first appeal as well as other provisions regarding time limit, exemptions etc., as provided in the RTI Act, 2005 will continue to apply.
